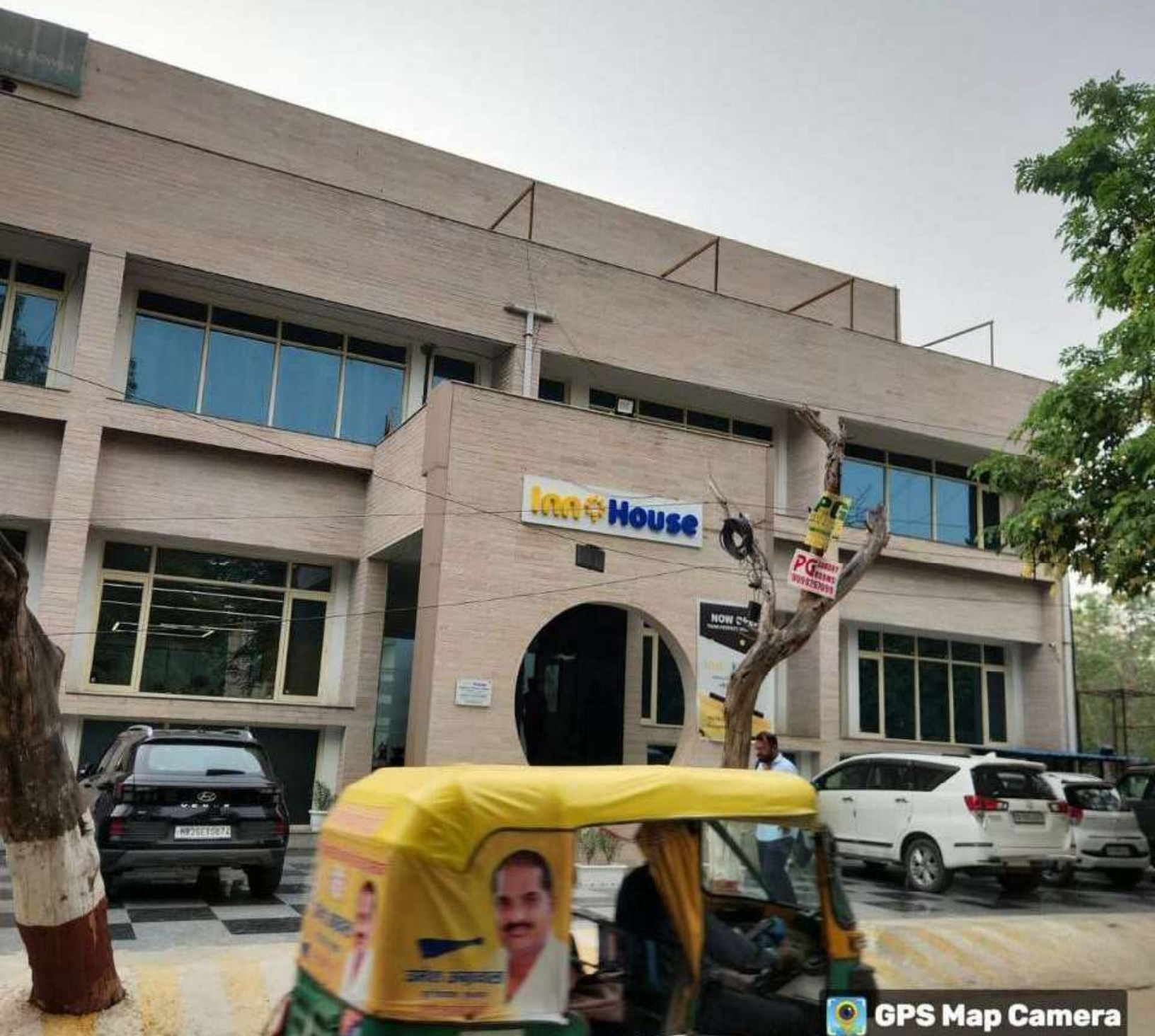

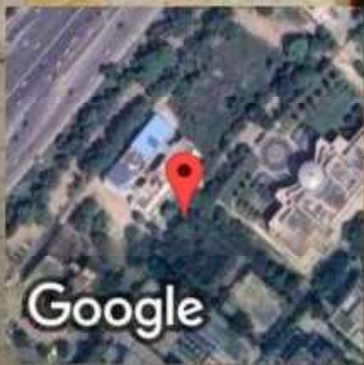

Subject: Clarification on the paid-up preference Share capital of the Company reported in Form MGT-7

Respected Madam/ Sir,

This is with reference to the filing of Form MGT-7 for the financial year ended 31 March 2025 by Mensa Brand Technologies Private Limited ("the Company").

We wish to submit that, while filing Form MGT-7, we were unable to properly reflect the paid-up preference share capital of the Company due to a technical limitation. At the beginning of the financial year, the Company had 39,570 Optionally Convertible Redeemable Preference Shares (OCRPS) having a face value of ₹1,000/- each, issued at a premium of ₹4,042/- per share, which were partly paid up to the extent of ₹1/- per share.

On 14 February 2025, the Company made the first and final call and received the balance amount of ₹5,041/- per share. However, the receipt of the call money could not be properly reflected in Form MGT-7.
